Re-Enrollment & Volunteer Screening

Keep reminding everyone in your club and your friends to reenrolled on 4-H Online! We need to get everyone re-enrolled as soon as possible. If they plan on participating in club day, any camps, conferences, or exhibiting at the county fair

they'll need to enroll before they can do that. The last day to change, drop or add a project is May 1. Also note that in order to weigh-in any livestock, the exhibitor must be enrolled before weigh-in.

If you are a current screened volunteer in your 4-H club and plan to continue to do so, please complete and return your Renewal Form to the Extension Office. Everything can be completed at 4-H Online, just click on your name and edit, go to volunteer resources section and click on screening or renewal. If you have questions please contact Regina and she can walk you through it. They are also available on our website or can be found on-line at www.kansas4-h.org and click on the Volunteer link for a form-fillable version.

If you have any questions on what you still need to complete on your 2019 volunteer paperwork, please contact the office!

LIVESTOCK WEIGH-IN DATES—

If you are planning on showing livestock this year at the County Fair, **you MUST** weigh and tag your livestock at the respective weigh-in dates. **Beef weigh-in has been set for Thursday**, **February 7 from 4:00-6:00 p.m.** at Winter Livestock. In case of bad weather that day, it will be moved to Thursday, <u>Feb. 21</u> You will be notified if it changes. Small livestock weigh-in will be Tuesday, April 16, 4:30-6:30 p.m. at the Fairgrounds.

A service charge of \$25 will be applied per trip to tag animals for other shows not brought to respective weigh-in dates. What if the 4-H'er is unable to be at the weigh-in? No worries, the ANIMAL can be brought to the weigh-in by anyone. If you have questions, just let us know!

EAR TAG POLICY 4-H Council policy allows a 4-H'er up to six (6) ear tags per species (i.e. up to 6 for beef, 6 for sheep, 6 for goats, 6 for swine). Any tags over the provided six will be at the expense of the 4-H'er and their family and will need to be reimbursed to 4-H Council.



The 2019 Kansas Junior Meat Goat Producer Day will be hosted on Saturday, March 30, 2019 in Weber Arena on the K-State campus in Manhattan. This one-day educational event is devoted to the selection and management of youth meat goat projects. All ages and knowledge levels are invited! K-State faculty members, graduate students, and guest speakers will cover topics including selection, meat science, nutrition, the state nomination process, herd health, reproduction, health and wellness, facilities and equipment, & showmanship. An optional instructor-led YQCA session will also be held at the conclusion of the program (approx. 2:30pm).

The cost for Junior Meat Goat Producer Day is \$15/person, if registration is submitted by March 11, 2019, or \$20/person after the early deadline. All attendees, including youth and adults, must register. All participants who sign up by Mach 11 will also receive a t-shirt. Families may register online at http://bit.ly/ksuasiregister, or by downloading the flyer (http://bit.ly/ksujrproducerdays), completing the bottom portion of the flyer and mailing it, with payment, to the K-State Youth Livestock Program. Those who indicate they would like to participate in the optional YQCA certification will receive additional details and instructions via email in late March. The KSU Sheep & Meat Goat Center will also be hosting their annual sale following the junior day program. They are separate events, but the schedule will allow families who would like to attend both events to do so.

The Kansas Junior Swine Producer Day is scheduled for Saturday, March 9, 2019 in Weber Arena on the K-State campus in Manhattan. This one-day educational event is devoted to the selection and management of youth swine projects. All ages and knowledge levels are invited! K-State faculty members, graduate students, and guest speakers will cover topics including selection, meat science, ear notching, breeds, the state nomination process, herd health, nutrition, and showmanship. An optional instructor-led YQCA session will also be held at the conclusion of the program.

The cost for junior swine producer day is \$15/person, if registration is submitted by February 15, 2019, or \$20/person after the early deadline. All attendees, including youth and adults, must register. Those who sign up after the deadline cannot be guaranteed a t-shirt. FORD COUNTY FEE POLICIES—EFFECTIVE JANUARY 1, 2014

REMINDER OF OUR FEE'S POLICY

- For any activity registration: Payment arrangements can be made in writing with the Extension Office to set up a payment schedule. *Full payment is due by the registration deadline*.
- For online registrations: <u>Full payment is due to the Extension Office by the online event deadline unless a written payment agreement is made between the Extension Office and the participant.</u> Failing to meet those requirements will result in cancellation of registration (participant will still be responsible for the \$25 cancelation fee and possible registration cost based upon event guidelines.)
- Transportation: A transportation fee of \$10 per person will be added to fees for trips that require travel in a county vehicle outside of Ford County (ex. Advanced Master Gardener training, State FCE Conference, KS Youth Leadership Forum, Discovery Days, Camp at Rock Springs, judging events, etc.)
- **Tagging Livestock:** A service fee of \$25 per trip will be charged for trips made to tag livestock for state shows or to re-tag livestock that have lost their original tags.
- **Transportation for Other Counties:** Ford County will require a \$25 per person to transport participants from other counties to events.

What is it?

Ford County Guidelines

Youth for the Quality Care of Animals (YQCA) is a new, national, multi-species youth livestock quality assurance program that covers food safety, animal well-being and character development through age-appropriate educational curriculum.

Who needs to get certified?

Any youth 7 years of age and older who will be exhibiting a market or breeding animal in the Ford County Fair (market only), Kansas State Fair Grand Drive or Kansas Junior Livestock Show (KJLS) is required to obtain certification. YQCA certification numbers will be submitted through the nomination process for market animals, and at the time of entry for exhibitors who only have registered purebred breeding animals. All youth should complete the training by June 15, 2019.

How do youth get certified?

Youth may earn their certification in one of the following ways:

- Instructor-Led Training (\$3 per child)
- Online Course (\$12 per child)
- Test-Out Exam (12 & 15-year-olds only; online course only; \$36 for 12-year-olds and \$48 for 15-year-olds)

Instructor-led sessions may be offered at the local level by certified instructors. Visit www.yqca.org for more details and to register for a class. All youth must pre-register through the YQCA website and pay the appropriate fee, regardless of the type of training they select, in order to obtain a certification number. Families should use their 4HOnline credentials to log in, create an user account and register for training. At completion of course, certificate should be printed off by individual.

How do youth test-out?

There is no test-out option for juniors. The online test-out is available only for 12 and 15-year-olds (first year intermediate and senior age divisions). Youth have one opportunity to pass a 50-question exam, with a score of 80% or better, for certification. Families will still have to pay the annual fee for certification for the entire age bracket, which is \$36 for a 12-year-old and \$48 for a 15-year old. However, eligible youth do not have to pay the fee to attempt the exam. If a young person passes the exam and subsequently submits the appropriate payment, they will receive a multi-year certification. A young person who does not pass will be prompted to complete the annual training, either through instructor-led class or online course.
